#### I. CALL TO ORDER/ANNOUNCEMENTS

Chairman Travis Napper called the meeting to order at 8:30am and thanked everyone for attending. Travis recognized Donna O'Daniels and the Northshore for hosting a festive board reception and dinner the evening prior at Annadele's Plantation.

Donna welcomed the board to the Northshore and announced that St. Tammany has had a great year. St. Tammany is working with the Lt. Governor on a Fontainebleau State Park project.

Secretary Ben Berthelot called the roll and quorum was present.

## II. APPROVAL OF BOARD MINUTES

Approval of September 19, 2018 Board of Directors Meeting Minutes.

ACTION #1: Mark Romig moved to accept minutes of the September 19, 2018 board meeting. Marion Fox seconded the motion. Motion carried.

### III. FINANCIAL REPORT

A. Kathleen Rainey presented the Balance Sheet as of October 31, 2018, that Checking/Savings \$267,307.64, Accounts Receivable \$177,198.00, Other Current Assets \$33,276.13 along with Fixed Assets \$461,839.90 bringing Total Assets to \$939,621.67. Total Current Liabilities Accounts Payable \$176,388.05, Other Current Liabilities \$158,581.18, along with Total Equity \$604,652.44 and which includes a new loss of (\$65,556.73) brought Total Liabilities & Equity to \$939,621.67.

The 2018 Profit & Loss had Total Administration Revenue \$80,987.45, LTA Membership Income \$194,147.48, Total Income \$2,124,736.99. Cost of Goods Sold \$1,295,417.48, Gross Profit \$829,319.51, Operating Expenses \$872,620.75, Other Net Loss (\$22,255.49), Net Loss \$(65,556.73). We were over our expected loss by (\$4,298.15).

Jill discussed the \$36,000.00 spent on the branding campaign. LTA has absorbed what we could of the branding expenses within this year's budget and capitalized the remainder. All of the expenses hit cash accounts and the rest is in the depreciation schedule and has landed on the balance sheet.

Other issues affecting cash flow: 1) Miles Media will receive invoice for their \$50,000.00 in royalty fees in December. LTA usually bills Miles in September but agreed to bill in December in 2018. Payment expected in January 2019. This payment for 2019 Visitor's Guide royalty fee has steadily been reduced over the year. The fee for

2018 guide was \$70,000. 2) The State has been billed \$35,000 for Culinary. The payment is expected in January 2019.

Believe nothing major will happen in the upcoming session -budget surplus and election year. Focus on the local level and protecting our funding at the local level. 5 of the 6 bills from this year's sessions were related to local elected leaders/communities coming after what has historically been funding for tourism marketing efforts -VEF and Occupancy Taxes. To prove our worth as an industry, our DMO's will need accurate research, strong public relations efforts, impeccable record keeping and full transparency.
